ORDINANCE NO. 2021 - 32

AN ORDINANCE AMENDING ORDINANCE 2021-02, THE BUDGET FOR THE CITY OF SEARCY FOR THE CALENDAR YEAR 2021; WAIVING THE REQUIREMENT OF COMPETITIVE BIDDING WITH RESPECT TO CERTAIN EXPENDITURES; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SEARCY, ARKANSAS, TO-WIT:

<u>Section 1</u>. The budget for the City of Searcy, Arkansas, is amended in the following manner:

- a. Appropriate \$3,300.50 to General Fund 'FEDERAL FORFEITURES' revenue account (#01 4-000-20-04), and appropriate \$3,300.50 to Police Department 'FEDERAL DRUG FORFEITURE EXPENDITURES' expenditure account (#01 5-060-05-10);
- b. Appropriate \$1,600.00 to the General Fund 'POLICE DONATIONS' revenue account (#01 4-000-90-03) and appropriate \$1,600.00 to the Police Department 'DONATIONS EXPENSED' expenditure account (#01 5-060-05-06) for donations received;
- c. Appropriate \$100.00 to the General Fund 'RECREATION DONATIONS' revenue account (#01 4-000-90-08) and appropriate \$100.00 to the Parks and Recreation Department 'DONATIONS EXPENSED' expenditure account (#01 5-080-05-10) for donation received;
- d. Appropriate \$224,955.82 from Special 1% Connector Route Tax Fund unappropriated reserves to the 'NORTH MAIN STREET IMPROVEMENTS' expenditure account (#13 5-900-54-03) for construction services on the North Main Street improvement project;
- e. Appropriate \$13,251.75 to the 2014 Eight Year Plan Fund 'LIBRARY RENOVATION REIMBURSEMENT' revenue account (#14 4-000-70-03) and appropriate \$13,251.75 to the 'LIBRARY RENOVATION' expenditure account (#14 5-020-54-02) for architectural services on the new Library Building renovation project;
- f. Appropriate \$13,000.00 from 2014 Eight Year Plan Fund unappropriated reserves to the 'SOUTH SAWMILL ROAD IMPROVEMENTS' expenditure account

- (#14 5-900-54-07) for engineering services on the South Sawmill Road improvement project;
- g. Appropriate \$2,800.00 from 2014 Eight Year Plan Fund unappropriated reserves to the 'CLOVERDALE DRAINAGE PHASE 2' expenditure account (#14 5-130-05-08) for surveying services;
- h. Transfer the following amounts from the Fire Department General Fund accounts:
 - Transfer \$3,000.00 from #01 5-070-01-14 TURNOUTS to #01 5-070-03-05 TIRES
 - Transfer \$3,000.00 from #01 5-070-05-20 OPTICOM to #01 5-070-05-01 EQUIPMENT
- i. Transfer the following amount from the 0.25% Fire Protection Services Fund accounts:
 - Transfer \$5,000.00 from #18 5-070-05-01 TURNOUTS to #18 5-070-05-20 STATION FURNISHINGS

<u>Section 2</u>. The Mayor and City Clerk are authorized to expend the following sums:

- a. \$23,444.94 to Stephenson Oil Company for fuel for all departments;
- \$1,091.25 to Hoffmann Architectural for architectural services on the American
 Legion building renovation project (#01 5-010-05-21);
- c. \$224,955.82 to Township Builders, Inc., for construction services on the North Main Street improvement project (#13 5-900-54-03);
- d. \$13,251.75 to Hoffmann Architectural for architectural services on the new Library building renovation project (#14 5-020-54-02);
- e. \$13,000.00 to Davidson Engineering for engineering services on the South Sawmill Road improvement project (#14 5-900-54-07);
- f. \$2,800.00 to Quattlebaum Surveying, LLC for surveying services (#14 5-130-05-08);

<u>Section 3</u>. To the extent not otherwise required by law, the requirement of competitive bidding with respect to the expenditures described in Section 2 hereof is hereby waived.

<u>Emergency Clause</u>. The need to maintain the fiscal affairs of the City of Searcy in accordance with the requirement of law being necessary for the preservation of the public peace, health, safety and welfare, an emergency is hereby declared and this Ordinance shall be in full force and effect from and after its passage.
